**NOW THIS DEED OF TRUST WITNESSETH:**

The Authors of the Trust do hereby constitute a Public Charitable Trust with the object detailed hereunder for which they dedicate by way of an initial corpus fund a sum of Rs.5000 /- (Rupees five Thousand Only).

I. That the name of the trust shall be "SILVER LEAF EDUCATIONAL TRUST"

II. The office of the Trust shall be at Present at 1/123 B, Kullegoundan Pudur, Periyandipalayam, Mangalam Road Tirupur-641687

III. The objects of the Trust are:

**EDUCATION:**

1) To open, establish, construct, maintain, run, develop, improve and extend and aid in the opening, establishment, construction, maintenance, running, development, improvement and extension of educational institution of general and technical nature.

2) To assist educational Institutions by providing necessary finance and other help.

3) To start establish and run:-

a) Schools, colleges, institutions, model farms, etc., for the study of agriculture, horticulture and other subjects.

b) Schools, colleges and training centers for mentally and physically handicapped and other institutions for their benefits.

c) Institutions for imparting vocational training for the benefit of the general public.

d) Hostels for students and orphanages and other homes for poor and orphaned pupils, whether studying in schools, colleges or other institutions.

e) Public libraries both for the benefit of the students and for the public.

f) To construct and maintain institutions, to encourage and impart education in various aspects of any curriculum.

g) To give financial aids by grants to deserving students studying in the institutions

h) To construct establish and maintain boarding houses or hostels for students to establish and maintain libraries and reading rooms.

i) To promote education for poor and deserving students by grants of scholarship to students.

j) To provide financial aids to people in need for marriages, education or any other purpose to establish, run or to give financial assistance for orphanage.

k) To run, establish hospitals, and to give financial assistance to people in need for medical treatment.

l) To construct auditorium, library and etc.,

m) The application of the Trust-Estate assets and funds shall be done without distinction of Nationality, Religion, Caste, Class, or Sex.

4) To grant scholarships, free books, free uniforms etc., to deserving students.

5) To aid by donations or contributions to Institutions having similar object and purposes.

6) To conduct seminars on educational advancements, international relationship etc.,

**RELIEF OF THE POOR:**

To give financial or other assistance in cash or in kind by way of distribution of books, notebooks, clothes, uniforms, or meals for the poor and indigent.

**MEDICAL:**

To provide and promote medical relief service without profit motive:

a) Treatment of all illnesses, preventing illness, establishing running, maintaining or assisting clinics, hospitals and their medical institutions, medical college are other para-medical training for various categories assistance required for medical treatment.

b) To give grants, subsidies or other assistants by medical camps for medical treatments and arrange such financing of such programmes or such other help as would be necessary in the circumstances of each case.

c) Co-opted with other institutions engaged in treatment and research by having joint programmes for conducting conferences and seminars or by having any other joint project relating to medicine.

d) To arrange for supply of medical equipments for medical institutions and supply medical and surgical treatment of patients and giving them institutional care and give free medicine.

e) To undertake any other institutional activities consistent with the above objects.

So, however, the objects set out above will be subject to following restriction:

i) There will be no profit motive, whatsoever and all its activities would be promoted solely by service motive.

ii) The trust will not embark on any business or activity not related to its object.

iii) The application of the trust estate assets and funds shall be done without distinction of Nationality, Religion, Caste, Class or Sex.

**IV. TRUST BOARD:**

1. The Life Trustees are :

A. Mr. M.Padmanabhan, S/o Mr.Muthukumarasamy, residing at 2/181 (Old no, 2/60B), Andipalayam, mangalam road, Tirupur – 641 687.

B. Mrs. P.Gomathi W/o Mr.Padmanabhan, residing at 2/181 (Old no, 2/60B), Andipalayam, mangalam road, Tirupur – 641 687.

1. The above named life / first Trustees have accepted to hold the office of Trustee(s) of the above Trust from this day onwards and decided to the work for the uplift of the above Trust. These first Trustees shall hold office for lifetime or until he / she resigns.

2. Each of the life / first Trustee(s) can nominate only their legal heirs as Trustees and he / she shall hold office, only after the life / first Trustee(s) lifetime, until he / she resigns or for his / her lifetime. If there is no legal heir they can nominate anybody.

3. If for any reason, the office of the present life / first Trustee(s) falls vacant without any nominations of the successors, only legal heirs can become the Trustee with power to nominate his / her successors as Trustee(s).

4. The Life / first Trustee(s) shall have power to co-opt one or more trustees and shall determine term of office of the so co-opted trustees.

5. The Life / first Trustee(s) shall have power to remove the co-opted Trustees without assigning any reason.

6. The life / first Trustee(s) shall elect one among themselves as **MANAGING TRUSTEE** whose office shall be co – exist with his / her Trusteeship. The Managing Trustee shall administer and manage the Trust and exercise all such powers of the Board as may be delegated. The Managing Trustee shall hold office for his / her life time or until he / she resigns whichever is earlier. The first Trustees are eligible for reappointment as Managing Trustee.

7. Mrs. P.Gomathi shall be the Managing Trustee of the Trust. The Managing Trustee shall administer and manage the trust and exercise such powers as may be delegated by the Board from time to time.

8. The first Trustee(s) may co-opt any other person of the Trustee who shall hold office for one to three years and may be re-nominated on the recommendation of the first Trustee(s) and further such nominated Trustee will not have the right to nominate any person as Trustee in the position held by him / her.

9. The total number of Trustees shall not exceed seven

**V. POWERS OF THE TRUSTEES:**

1. All the properties, funds and assets of Trust shall vest in the Trustees and they shall be in complete management control of the affairs of the Trust.

2. The Managing Trustees shall have power of administration, employment, removal of employees etc., A secretary may be appointed by the Managing Trustee to look after the day to day administration of the Trust.

3. The Board of Trustees may meet for the conduct of business, adjourn and otherwise regulate their meetings, as they think fit. The Managing Trustee shall summon meeting of the Board of Trustees. The decision of the majority in the meeting is binding upon the Board of Trustees. The Chairman of the Board of Trustees shall be entitled to exercise one additional casting vote in the event of equality of votes.

4. The Trustees shall have power to augment the funds of the Trust from any source by accepting donations, voluntary contributions of any kind if they think such acceptance is in the interests of the Trust.

5. The Managing Trustees shall have the power to appoint an auditor and legal advisor for the Trust.

6. Without prejudice to the above such general powers, the Trustees shall have powers:-

a) To buy negotiate and enter into contracts, rescind and vary such contracts, make advances upon and pay for the purchase of all materials, stores, machinery and other goods required;

b) To purchase, lease license, let out, provide erect, maintain and keep up lands, buildings, equipment and materials and to sell, mortgage or dispose of all or any of the same as the Trustees may think fit.

c) To execute, become party to, sign, acknowledge, perfect and register all deeds, agreements and to give effectual discharge on behalf of the Trust:

d) To borrow from time to time such sums of monies for such period on such terms with or without security as the Trustees may think fit.

e) To draw, make, accept, endorse, discount, negotiate, execute and issue promissory notes, bills of exchange, hundies, cheques, Government and other securities and other negotiable instruments.

f) To initiate, conduct defend, compound, withdraw, compromise, adjust, refer to arbitration or abandon any legal or other proceedings, claims or disputes, by or against the Trust or Trustees or against its officers or employees concerning the affairs of the Trust and to sign and verify vakalath, plaints statements, execution petitions, affidavits and other proceedings;

g) To open and close accounts with Banks, to operate upon any such accounts, to pay and draw money from such accounts and to borrow such amounts as required for the trust from the bank with or without security or otherwise deal with the same; and the

Powers in this behalf may be exercised by the Managing Trustee or jointly with any other Trustees, if required and empowered by a resolution of the Board of Trustees in a meeting.

h) To insure and keep insured, if deemed expedient, all or any of the buildings and other assets of the Trusts.

i) Generally to carry out transactions as they consider expedient in the interest of the Trust and to make all such arrangements and do such acts and things on behalf of the Trust as may be usually necessary, desirable or expedient for the management of the affairs of the Trust or in carrying out its objects.

j) To invest the funds of the Trust only in accordance with the provisions of sections 13(1)(d) read with the section 11 (5) of the Income Tax Act.

k) Subject to the provisions of sections 11 to 13 of the Income Tax Act, the Trustees shall have the sole discretion in regard to the investment of Trust funds and the Income there from and the Trustees shall have the power to vary the investments from time to time and for that purpose may sell off, realize any of the Trust Properties.

**VII. ASSETS OF THE TRUST**

The Trust assets shall comprise of all funds received as donations whether as corpus fund or otherwise, all income from the investments, movable and immovable properties to be acquired by gift, purchase, lease or otherwise and all the properties shall be held in the name of the Trust.

**VIII. ACCOUNTS**

1. The accounts of the Trust shall be closed every year on 31<sup>st</sup> march and income and expenditure account and balance sheet as on that date shall be prepared. The surplus fund if not applied within the year of account shall be accumulated for any specific object of the Trust and invested in any manner authorized under the Income Tax Act for the time being.

2. The accounts of the Trust shall be audited every year by a qualified Chartered Accountant or by a firm of Chartered Accountants.

**IX. GENERAL**

1. This Trust shall be irrevocable.
2. ONLY the LIFE Trustees shall have power to add / amend the trust deed by majority decision subject to the approval of the Commissioner of Income-tax.
3. No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of section 2(15),11,12 and 13 and 80G of the Income tax Act, 1961 as amended from time to time.
4. Income and funds of the trust shall be solely utilized towards the objects of the trust and no portion of it will be utilized for payment to Trustees by way of profit, interest, dividends etc.,
